Pilot Program for Climate Resilience (PPCR) Second Joint Mission (WB/IFC-IDB) May 10-11, 2011

Aide-Memoire / Joint Mission Report



#### A. Introduction and Background

- 1. During the First Joint Mission held on August 9-10, 2010, it was jointly agreed with the Government of Saint Lucia (GoSL) and the Joint Mission that the World Bank would support the Sustainable Development and Environment Division within the Ministry of Physical Development and the Environment in preparing Saint Lucia's Strategic Program for Climate Resilience (SPCR). It was also agreed that the World Bank would procure, on behalf of the GoSL, a team of consultants to assist the Sustainable Development and Environment Division with the SPCR formulation process in close collaboration with the Ministry of Finance, Economic Affairs and National Development and relevant ministries / agencies of the GoSL to ensure the process is aligned and builds upon national strategic plans and priorities.
- The preparation of Saint Lucia's SPCR has involved a comprehensive process that included: 1) 2. national consultations, small focus group and one-on-one meetings held with key national stakeholders, policy makers and prospective beneficiaries about the pilot program, to confirm the strategic focus of the SPCR (a complete list of key national stakeholders groups involved in the SPCR design can be referenced in Annex 4); 2) stock-taking of relevant past, planned and ongoing climate change adaptation projects by the GoSL, Multi-lateral Development Banks (MDBs), development partners, the private sector and Civil Society (NGOs / CBOs) to ensure coordination of activities; 3) identification and prioritization of key investment needs; 4) an exhaustive desk-top study of existing national and regional development policies and strategies, including, inter alia, the Medium Term Economic Strategy and National Vision Plan, the National Climate Change Policy and Adaptation Plan, the National Environmental Strategy and related Policy, Second National Communication, the Organization for Eastern Caribbean States (OECS)' Saint George's Declaration (SGD) - Principles for Environmental Sustainability (2006), Saint Lucia's National Emergency Management Plan and associated documents, the Coastal Zone Management Policy, the National Water Policy, the National Land Policy, the Draft Saint Lucia Forest Policy, the National Biodiversity Strategy and Action Plan, to name a few. The exercise also included a review of past projects including, among others, the Initial National Communication to the UNFCCC (2001), the 2005 Knowledge Attitude and Practice (KAP) Climate Change survey of 2005, as part of a Vulnerability and Capacity Assessment (VCA) Project and the soon-to-be-completed Second National Communication to the UNFCCC and Special Program on Adaptation to Climate Change (SPACC) Projects.
- 3. A first draft of the SPCR and Investment Plan was submitted to the Joint Mission on May 2, 2011.

#### B. Mission Objectives

- 4. The Second Joint Mission was held with the intention of achieving the following objectives:
  - Technical input towards the advancement of the draft SPCR and Investment Plan, in preparation
    for submission prior to and presentation at, the PPCR Sub-Committee meeting to be held in Cape
    Town, South Africa in June 2011;

Dan Call Work

- A clear way forward and options for concessional financing for the private sector through the International Finance Corporation (IFC) and/or the World Bank;<sup>1</sup>
- Agreement in principle on the component and priorities of the Investment Plan; and
- Guidance on the enabling environment required for effective and timely implementation during Phase II.
- 5. The Second Joint Mission team comprised the World Bank, represented by Justin Locke, Disaster Risk Management Specialist Consultant and Galen Evans, Junior Professional Associate; the International Finance Corporation (IFC) represented by Noleen Dube, Sustainable Business Advisor and Kalim Shah, Resident Representative for Latin American and the Caribbean; and the Inter-American Development Bank (IDB) represented by Cassandra Rogers, Disaster Risk Management Lead Specialist and Pat Mendoza, PPCR Regional Consultant. Other partners were represented by Mizutani Danny and Kohei Hori from the Japanese International Cooperation Agency (JICA), and Peter Murray of the Organization of Eastern Caribbean States-Environment and Sustainable Development Unit (OECS-ESDU).
- 6. During the mission, the World Bank, the IFC, the IDB and other partners held extensive meetings over a two-day period with (i) the Sustainable Development and Environment Division's PPCR Team; (ii) key national stakeholders; (iii) Government agencies associated with the PPCR process critical among them being the Ministry of Finance, Economic Affairs and National Development and the National Emergency Management Organization; (iv) representatives from the private sector and civil society inclusive of wide representation by Financial Business Organizations (FBOs); and (v) key policy makers.
- 7. Conclusions of the mission were discussed in wrap-up meetings with IDB, IFC, the World Bank; Crispin d'Auvergne, Chief Sustainable Development and Environment Officer and PPCR-National Team Leader; Dawn Pierre-Nathoniel, Sustainable Development and Environment Officer and Coordinator of the national component of the PPCR; Laverne Walker, Sustainable Development and Environment Officer and Coordinator of the regional component of the PPCR; members of the Sustainable Development and Environment Division within the Ministry of Physical Development and the Environment, Rosilia Joseph, Project Officer- Financial Management, Myrtle Drysdale-Octave, Procurement Officer and Yasmine Anatole, Project Officer, Contract Management; members of the Project Coordination Unit (PCU) of the Ministry of Finance, Economic Affairs and National Development; and PPCR Lead Consultant, Luvette Louisy. The key findings of the mission are summarized below.

#### C. Key Mission Outcomes

8. The GoSL confirmed that an Investment Plan will be presented as part of its SPCR, within a range of US\$5-7 million in grants, with the understanding that the lower number will apply if the agreed CIF PPCR envelope for the Caribbean Pilot is at the lower range of US\$60 million, and that the higher number, if US\$75 million is available for the Caribbean Pilot. The GoSL expressed concern regarding the constraints of the budget, vis-a-vis the critical needs identified in its SPCR. The GoSL is still to confirm its request for concessional loans under the PPCR to supplement the US\$5-7 million grant allocation. The

concessional loan request will be based on the confirmed concessional loan envelope available to Saint Lucia. The grant allocation will support the GoSL's efforts to promote climate resilience in core development planning through an integrated cross-sectoral approach. The concessional loan allocation will support and promote private sector and civil society involvement in building climate resilience and fostering ownership for necessary action.

- 9. As indicated previously, the PPCR in Saint Lucia will be led by the Sustainable Development and Environment Division within the Ministry of Physical Development and the Environment, in collaboration with the Ministry of Finance, Economic Affairs and National Development, through the Permanent Secretary and inclusive of the PCU. The program will enable Saint Lucia to align and upscale its current practices to better address climate risk and vulnerabilities. It is expected that at the end of implementation of Phase 2, Saint Lucia will be able to more strategically and measurably begin to reduce climate vulnerability across different sectors, as well as lay the foundation that will allow for effective follow-up action.
- The Joint Mission advised the Sustainable Development and Environment Division of the 10. importance of defining targeted project(s) towards specific transformational change proposed for PPCR grant and concessional financing. It was advised that the project concept identification process be conducted jointly with the PCU within the Ministry of Finance, Economic Affairs and National Development, given that the PCU has had extensive experience with developing MDB projects and will be managing all fiduciary and procurement aspects of the proposed investment project(s). The need to collaborate with key agencies already involved in projects that are relevant to those identified for implementation during Phase 2 is also critical. As recommended by the CIF, it was advised that the GoSL give consideration to the blending (co-financing) of PPCR funds with other resources - such as World Bank International Development Association (IDA) funding. Recently, the GoSL requested to participate in the Regional Disaster Vulnerability Reduction Project (RDVRP) in which Grenada and Saint Vincent and the Grenadines are participating. The RDVRP would be a likely candidate for blending with PPCR resources, given the similar project preparation schedule and objectives, as well as the fact that there is strong commitment to the RDVRP within the OECS that would lend to a regional-focused approach that would, in turn, promote best practice, knowledge sharing and better utilization of resources.
- During the presentation delivered on Day 1 of the mission, the Sustainable Development and Environment Division outlined some of the key outputs of its Phase 1 process, outside of the preparation and submission of an SPCR and Investment Plan. These included: 1) Updated Climate Change Adaptation Policy (CCAP) (from the 2002 policy); 2) Climate Change KAP Study to build on the survey conducted in 2005; 3) Drafting Instructions for an Environmental Management Bill, Environmental Impact Assessment (EIA) and Physical Planning regulations to incorporate the climate change element; 4) Climate Change Public Education and Outreach Strategy and Implementation Plan (with a focus on special and vulnerable groups); 5) Recommendations for data procedures/protocols and for enhanced data management; 6) Basket of incentives to be implemented within and beyond PPCR to address climate change and the establishment of a data sharing tool for informed decision making, namely, a GeoNode Pilot. The mission was informed by Saint Lucia of the installation of the GeoNode software and the training/piloting currently underway in the country regarding the use of the platform as part of its PPCR Phase 1 process, and Saint Lucia's anticipation that: (1) there will be a parallel activity at the regional level that will facilitate the eventual linking of national GeoNodes with regional entities; and (2) resources will be allocated from its national PPCR grant allocation for the further expansion of the GeoNode platform as a data management tool for the government during Phase 2 of the PPCR.
- 12. During the Second Joint Mission, private sector and civil society participants from local banks, financial institutions, including the Saint Lucia Development Bank (SLDB), development foundations and several players in the hotel and tourism sector were provided with an overview of potential modalities

for engaging in the PPCR. The GoSL is interested in engaging the private sector and civil society in the design and implementation of adaptation activities in the PPCR. In this regard, the GoSL's request for concessional financing from the PPCR will be primarily targeted for the private sector and civil society adaptation. The main objective of providing concessional financing to the private sector and/or civil society is to catalyze investments by addressing market barriers (high costs and/or high risks), which will allow projects that would not otherwise happen. This will promote market transformation and sustainable markets. The concessional funding provided should strive to optimize concessionality and avoid undue market distortion. It is also recognized that some grant funding will be required for associated activities to prepare an enabling environment for the private sector to enter the climate adaptation market.

- 13. There is the possibility of concessional financing targeted at the private sector and/or civil society (and some minimal grants) flowing through the SLDB, with support from the World Bank or the funds flowing through the IFC directly to private sector clients. The GoSL indicated that it is investigating the possibility of utilizing both mechanisms, targeting different but complimentary markets, e.g. clients of the SLDB could be SMEs and individuals and IFC could engage more with larger firms in the hotel and tourism industry either directly or through local financial intuitions.
- 14. Key national stakeholders, the MDBs and development partners endorsed the following five strategic pillars (programmatic areas) outlined in the draft SPCR, which represent the SPCRs strategic program areas and key actions:

#### A. Human Welfare and Livelihood Protection

- Water Supply Augmentation through Conservation and Storage
- Safeguarding Health and Sanitation
- Food Security/Sustainability
- Community Vulnerability Reduction and Adaptation

# B. Integrated Natural Resource Protection, Conservation and Management to Promote Sustainable Development

- Integrated Watershed Planning Framework and Implementation
- Sustainable Land Management climate resilient Practices
- Coastal Resource/Zone Management Framework and Implementation

# C. Building Resilience through Business Development, Innovation and Productivity Enhancement

- Adaptation Financing Facility and Trust Fund
- Supply Chain Development in Support of Resilience Building
- Business productivity enhancement

#### D. Capacity Development/Building and Institutional/ Organisational Strengthening

- Enabling Environment
- Research and Systematic Observation and Data and Information Management
- Public Education and Outreach

#### E. Reducing Risk to Climate Related Disasters

- Comprehensive Disaster Risk Assessment Tools that incorporate climate risks
- Enhanced Early Warning Systems vis-a-vis Climate-Related Disasters
- 15. These five programmatic areas include actions targeting the following thematic areas: Water Resources and Integrated Water Resources Management; Coastal Resources/Zone Management;

Sustainable Land Management; Community Vulnerability Reduction; Private Sector Adaptation and Resilience Building; Food Security/Sustainability; Public (human, animal and plant) Health; Reducing Risk to Climate Related Disasters; and Information and Communication Management.

- The vision of the SPCR is a holistic and cohesive framework for building climate resilience at all 16. levels in Saint Lucia, thereby ensuring that the economic, social and ecological/environmental conditions contributing to climate change concerns are effectively addressed in the context of national sustainable development, for the benefit of all its citizens. The main goal of the SPCR is to clearly articulate the country's strategic response to expected/anticipated climate change risks, in a manner that simultaneously meets current and future social and economic development requirements and satisfies cultural and ecological needs, through, inter alia, measures that systematically incorporate climate change-related hazards/consequences in the development process. The primary objective of the SPCR is to undertake and support measures to promote and enhance climate-resilient development at all levels of society; (undertake climate change adaptation measures and actions to build resilience and demonstrate results at all levels of the society), to ensure a sustainable quality of life for the people of Saint Lucia. In addition, Saint Lucia has clearly articulated that its' SPCR is "PPCR and beyond". The SPCR is expected to further serve as an overarching guide of national significance for addressing climate change, to which all organisations can refer, in their preparation of project/programme proposals for building climate resilience. As such, the SPCR is expected to serve as the "blueprint" from which climate change projects can be developed from a national framework, rather than in an ad hoc manner.
- 17. The SPCR will integrate, as a key implementing tool, an updated National Climate Change Adaptation Policy, to provide an integrated framework for building resilience to the physical, biological and socio-economic impacts of climate change risks. In this regard, the SPCR will provide further opportunities for deriving synergies with current and emerging initiatives in climate change adaptation.

- 19. It was also jointly agreed with the Sustainable Development and Environment Division that funds remaining in the Phase 1 grant after the SPCR is submitted will be focused, as far as the budget will allow, on: completing and advancing Phase 1 activities, as outlined in paragraph 10; implementing other activities outlined in its approved Phase 1 proposal; enabling participation of a core team from Saint Lucia at the CIF forum in South Africa in June, including the presentation of the SPCR and Investment Plan and preparing the CIF PPCR Sub-Committee endorsed investment project(s) for implementation.
- 20. The GoSL also indicated its interest in requesting a Project Preparation Advance (PPA) for its proposed investment project(s). This will allow the GoSL to contract consultants and undertake the appropriate assessments and studies in preparation of their CIF PPCR Sub-Committee endorsed

PPCR and beyond means that it provides the broad project / program areas for all sectors, themes and areas, in pursuit of enhanced climate resilience, well beyond the timeframe of, or funding available under, the PPCR.
 Saint Lucia intends to plan for a range and present its SPCR and Investment Plan with a proposed project (s) for funding that

investment project(s). If the GoSL decides to blend its endorsed PPCR resources with IDA funding, the PPA could be funded from IDA Project Preparation Facility funds. If the GoSL decides not to blend their PPCR, the requested PPA would be funded through the CIF and is understood that it could take additional time.

#### D. Next Steps

21. Saint Lucia's final SPCR and Investment Plan will be submitted to the Climate Investment Fund's PPCR Steering Committee by June 3, 2011 in order to be presented at the PPCR Sub-Committee Meeting to be held in Cape Town, South Africa, June 28-29, 2011.

This letter serves as Saint Lucia's official notification of its Second Joint Mission under the Pilot Programme for Climate Resilience (PPCR). This is a collaborative effort at the national level between the executing agencies of the Ministry of Physical Development and the Environment and the Ministry of Finance, Economic Affairs and National Development.
