**OBSERVERS IN THE CIF GOVERNING BODIES** 

### **Proposed Decision by the Joint CTF and SCF Trust Fund Committees**

The joint meeting of the CTF and SCF Trust Fund Committee reviewed document CTF-SCF/TFC.6/5, *Observers in the CIF Governing Bodies*, and takes note of the short term improvements that have been put in place by the CIF Administrative Unit. The joint meeting welcomes the feedback and recommendations from the stakeholder consultations among the CSO groups, private sector groups, and indigenous peoples groups and agrees that the following steps should be taken to strengthen the engagement of observers in the CIF Trust Fund Committees and Sub-Committees:

### I. BACKGROUND

- 1. At its joint meeting in November 2011, the CTF and SCF Trust Fund Committee reviewed document CTF-SCF/TFC.5/7, *Review of the Self-Selection Process for Observers to CIF Committees and Effectiveness of Participation*, and took note of the results of the independent review of the self-selection process for, and effectiveness of participation of observers to the CIF Committees.
- 2. It welcomes the recommendations by the current observers for short and long-term improvements of the process and requested the CIF Administrative Unit to implement proposed short-term actions immediately. With regards to the proposed modifications, the joint meeting requested the CIF Administrative Unit to organize further consultations with interested stakeholders during the 2011 CIF Partnership Forum, and to report on those consultations together with costed proposals, for further consideration by the joint CTF and SCF Trust Fund Committees at their joint meeting in June 2011.
- 3. This paper has been prepared in response to that request. The document includes information on
  - (i) steps that have been taken on short-term measures
  - (ii) consultations for CSO observers during the 2011 CIF partnership Forum in Cape Town, South Africa; and
  - (iii) the process for the self selection of CIF observers for the upcoming term.

# II. SUMMARY FROM THE REVIEW OF THE SELF-SELECTION PROCESS AND THE EFFECTIVE PARTICIPATION OF OBSERVERS IN CIF COMMITTEES

- 4. Two reviews of participation of observers were conducted in 2010: IUCN was commissioned to review the process for observers from non-profit civil society, including the self selection process which was facilitated by RESOLVE, and the IISD was commissioned to prepare a review pertaining to the private sector observers and their self selection process which was facilitated by the World Business Council on Sustainable Development. The reviews recognized that the CIF had initiated a new and promising model of observer participation in the international context of climate finance that could contribute to a new relationship with non-profit civil society organizations and the private sector.
- 5. Both reviews concluded that substantial changes were needed in the selection process and engagement of observers in meetings of the CIF governing bodies to ensure continued active engagement and interest in the CIF. In this context, the reports call for clarity on the roles and responsibilities of observers and expectations in the deliberations of CIF meetings.
- 6. It was emphasized that both constituencies, non-profit civil society as well as the private sector, have great potential to engage in a more meaningful way in the deliberations of the CIF governing bodies. It was concluded that this potential needs to be better understood to be fully beneficial to the CIF process.

- 7. The reviews brought forward several recommendations concerning the selection process and proposals to improve engagement of the private sector with the CIF. The majority of the recommendations pertaining to the functions of the CIF Administrative Unit has been implemented or is in the process of being implemented. Other recommendations concerning the civil society observer process will require, as anticipated, further consultations during the Partnership Forum.
- 8. The following matrix summarizes the recommendations and proposals for follow-up. The matrix includes additional measures that were initiated by the CIF Administrative Unit to respond to the request of the joint meeting.

## III. STATUS OF CIF CSO OBSERVER CONSULTATIONS AT THE 2011 CIF PARTNERSHIP FORUM AND SELF SELECTION PROCESS

9. The CIF Administrative Unit, building on the experience gained by RESOLVE<sup>1</sup> and World Business Council for Sustainable Development<sup>2</sup> (WBCSD) in carrying out the first self selection process for CSOs and the private sector, respectively, commissioned these two organizations to assist in preparing the stakeholders consultations in Cape Town as well as advancing views on the self selection process. Consultations with Indigenous Peoples Groups and Local Communities were initiated as part of the consultative process for the design of the *Dedicated Grant Mechanism* under the FIP<sup>3</sup>. Provision has been made in the schedule for all three stakeholders group to convene on Thursday, June 23, in advance of the Partnership Forum.

### IV. CONSULTATION PROCESS FOR NON- PROFIT CIVIL SOCIETY

10. RESOLVE sent a list of questions to all current CIF CSO observers and initiated small-group conference calls during the weeks prior to the Partnership Forum with all interested current observers and alternates. The purpose of these calls was to discuss the recommendations from the IUCN review and collect observers' ideas for how to improve the upcoming observer selection process. RESOLVE will prepare a summary document of the feedback generated in all of the small-group conference calls with a view to capture suggestions, areas of agreement, and areas that require additional discussion. During the 2011 CIF Partnership Forum, prior to a half day consultation with a larger group of observers, RESOLVE will facilitate a half-day meeting of current observers to discuss and agree on a way forward. RESOVLE will then prepare a final report with recommendations.

#### V. CONSULTATIONS PROCESS FOR PRIVATE SECTOR

11. The WBCSD developed an e-questionnaire for current observers, business organizations and selected companies. The questionnaire, directed at a mixture of business and organizations was sent to all WBCSD members and regional networks, ICC circulation lists, and to BINGO organizations under the UNFCCC. A follow-up webinar to communicate and discuss results was

held with some CIF observers from the private sector and the CIF Administrative Unit. Based on the results of the questionnaire, WBCSD will develop a set of recommendations for discussions during the private sector consultations and agree on next steps. WBCSD will also design and organize the private sector consultation session during the 2011 CIF Partnership Forum to (i) facilitate the development of proposals for short and long term improvements of the self selection process for private sector observers and (ii) enhance the effectiveness of participation by the private sector in the CIF. Recommendations from the business community will be formulated as a basis to launch the next self-selection process.

#### VI. CONSULTATION PROCESS FOR INDIGENOUS PEOPLES GROUPS

- 12. During the global meeting of **Indigenous Peoples Groups and local communities** for the development of the *Dedicated Grant Mechanism for Indigenous Peoples and Local Communities* under the Forest Investment Program which took place in Bangkok, Thailand in April 2011, the indigenous peoples groups received a full briefing on the observer seats in the SCF Trust Fund Committee and Sub-Committees as well as the roles and responsibilities of observers in the CIF process. The indigenous peoples groups took note of this input and decided that the legitimate forum for making the decision on IP representation in these governing bodies is the UN Permanent Forum for Indigenous Peoples Issues (UNPFII). The meeting of the UNPFII was held in May 2011 in New York. Results from that process are to be shared with the CIF Administrative Unit shortly.
- 13. The IPs requested the CIF Administrative Unit to collate all relevant information on "active observers", including a list with current observers, the observer guidelines and seat distribution by Committee into one document. This document was shared with the indigenous peoples groups in April 2011.

### VII. STATUS OF SELF SELECTION PROCESS

14. In consultations with CIF observers prior to the 2011 CIF Partnership Forum, the CIF Administrative Unit was informed that the CSO observers did not want to carry out a selection process during the Partnership Forum as the period of time involved would be insufficient for a full fledged selection process. The non-profit civil society organizations and private sector organizations will discuss proposals for a self selection process at the 2011 Partnership Forum and provide a proposal to the joint meeting of the CTF and SCF Trust Fund Committee at its meeting in June 2011. It should be noted that provision has not been made in the current budget proposal to finance a self selection process in FY12, and if any of the approved recommendations have budgetary implications, additional funds will need to be requested.
