

CIF-TAF will take a country-focused approach to creating and enhancing investment-enabling frameworks for *renewable energy* and *energy efficiency* investments. It aims to address key risks, bring down the cost of capital and, in the process, lead to the development of and investments in clean energy markets.

Share lessons learnt from past experiences in a range of sub-sectors (e.g. EE in buildings, etc.) and issues (regulations etc.) globally.


Promote private sector engagement Share experiences related to private sector engagement as part of ongoing dialogs with governments and other key stakeholders.
