









Gigaton strategic investment targets

CLIMATE INVESTMENT AS TOP PRIORITY

Growth in the sector is mirrored by interest from major international investors. **SunFunder has been shortlisted by** the UN-convened Net-Zero Asset Owner Alliance in their call for proposals seeking blended finance vehicles with a focus on climate investments (alongside BlackRock and Allianz EM infrastructure funds).

Challenges experienced in fundraising

- Sector is not really known by mainstream private institutional investors
- Some private investors are looking higher liquidity than is easy to provide with private market investments
- Size of the fund (too small / too big)
- Size of the individual ticket (additionality DFIs / Private sector)
- Difficulties for blended finance fund: Not easy to find catalyst junior investors, some DFIs rejects Blended finance vehicle (not eager to finance fund or to trade off risk/ return), while blended finance could take high country and sectorial risks
- Need to balance portfolio need for scale and impact
