

## **Terms of Reference**

### **First Joint Mission to Support Uganda in Developing the Strategic Plan for Climate Resilience (SPCR) for the Pilot Program for Climate Resilience (PPCR)**

#### **1. Summary**

A First Joint Mission of the Government of Uganda (GoU), the Multilateral Development Banks and other partners is planned in Uganda from 13 – 24 June 2016. The overall objective of this mission is to support the GoU to elaborate its Strategic Plan for Climate Resilience (SPCR) under the Pilot Program for Climate Resilience (PPCR) , through (i) finalizing and firming up the SPCR’s priority activities and key analytical studies to inform the SPCR, and (ii) reviewing and refining the first draft of the SPCR. The mission will be led by the GoU’s Ministry of Water and Environment (MWE) through the Climate Change Department (CCD), and supported by the Multilateral Development Banks (The African Development Bank – the Lead MDB for PPCR in collaboration with the World Bank). At the end of the Joint Mission, an Aide Memoire will be produced highlighting the confirmed SPCR priority activities and identified analytical studies, agreed activities for collaboration with the parallel FIP Investment Plan (IP) and a revised SPCR preparation roadmap.

The First Joint Mission will build on the technical mission of 16 – 25 March 2016 and the initial joint scoping mission of 19 – 23 October 2015. The scoping mission consulted and introduced various stakeholders to the SPCR process, and guided the prioritization of thematic areas for the SPCR. The subsequent technical mission (i) finalized implementation and fiduciary arrangements for the Phase 1 activities, (ii) identified initial activities for the SPCR thematic areas through multi-stakeholder consultations, and (iii) reinforced consultation mechanisms and collaboration opportunities with development partners, civil society and other stakeholders.

#### **2. Background and Country Context**

Uganda’s expression of interest to develop the Strategic Program for Climate Resilience (SPCR) for the Pilot Program on Climate Resilience (PPCR) and an Investment Plan (IP) for the Forest Investment Plan (FIP) was approved by the Climate Investment Funds (CIF) on 14 May 2015. The approval made available US\$ 1.5 million for Uganda to prepare the SPCR and US\$ 250,000 to prepare the FIP Investment Plan. During the Scoping Mission in October 2015 it was agreed that the grants be executed by the Government of Uganda. Subsequently, the GoU prepared the Proposal Preparation Grant (PPG) request to the CIF Administration Unit for the SPCR preparation which was approved in January 2016. The PPCR preparation grant is financing a range of activities including institutional capacity assessment and support, and technical studies that will inform the SPCR for the country. The PPCR program will support Uganda to transform its development plans and investment programs to address climate risks and vulnerabilities, building on the National Vision 2040, National Development Plan II – NDP II (2015-2020), National Climate Change Policy (2015), NAPA (2007), and other ongoing and planned relevant studies and strategies.

It is worth noting that the preparation of the SPCR is coinciding with the preparation of Country Strategic Development Program of the African Development Bank (AfDB) and the Country Program Framework of the World Bank (WB). The SPCR activities will thus be closely linked to the priority programs of both Multilateral Development Banks in their development strategies for Uganda.

**Uganda's Climate Change Context and Challenges:** The Ugandan economy and welfare of the people are intricately linked to the natural environment and are therefore highly vulnerable to climate variability and climate change. Climate and its impacts affect all sectors of economic development including agriculture, water, energy, transport, infrastructure, health and human settlements. For example, the country suffered economic losses of close to US\$ 470 million in food crops, cash crops and livestock following the 2010/11 droughts; likewise, floods and landslides caused numerous deaths, buried villages, and damaged crops, livestock and property in the Mountain Elgon districts of Bududa and Bulambuli in 2010-2012. Various climate projections for Uganda for this century indicate that the frequency and severity of such extreme weather events such as droughts, floods, landslides and heat waves will increase, as well as their associated negative impacts on society.

Uganda is committed to addressing climate change challenges and has taken major steps to create an enabling policy environment and to implement measures to adapt and mitigate climate change. It has to date prepared and submitted to UNFCCC the 1<sup>st</sup> and 2<sup>nd</sup> National Communications (in 2002 and 2014), NAPA (2007), INDC (2015) and other status updates. The National Climate Change Policy (NCCP) was approved in April 2015 and aims to “ensure a harmonized and coordinated approach towards a climate-resilient and low-carbon development path for sustainable development in Uganda”. The Government of Uganda is currently preparing the National Climate Change Bill (2016) to strengthen the legal basis to enforce the implementation of the NCCP including defining institutional responsibilities to mainstream climate change at sectoral and cross-sectoral level. The Government has also taken keen steps to integrate climate change into the NDP II as well as in some sectoral policies, plans, programs, and annual budgets and in some district local governments with effect from FY 2015/16 and will continue to do so for the new financial year 2016/2017. 17.

Uganda has also drafted a Green Growth Development Strategy (2016-2030), Climate Smart Agriculture Program (2015-2025), an Agriculture Sector Specific National Adaptation Plan (NAP), and a roadmap for preparation of the overall National NAP, among others. It is also supporting several other sectoral adaptation initiatives and projects to build resilience at various levels. The Climate Change Department (CCD) under the Ministry of Water and Environment (MWE) is the National Focal Point for the UNFCCC which coordinates all climate change issues in the country.

In spite of the current progress, the country still grapples with (i) weaknesses in institutional capacity at all levels, (ii) inadequate information systems and expertise to adequately assess, plan for and respond to climate risks. (iii) inadequate climate-resilient infrastructure to buffer against climate risks and provide secure and reliable services, and (iv) inadequate financing to adapt to climate change risks. Uganda prioritized 5 priority thematic areas for its SPCR, i.e. (i) *Climate resilient agriculture*, (ii) *Urban and rural resilience and infrastructure*, (iii) *Resilient landscapes*

*/water catchment management (including wetlands), (iv) Hydro-meteorological services, and (v) Strengthening institutional capacity in addressing climate change issues.* Proper formulation and implementation of actions under these priority SPCR themes is expected to greatly contribute to building climate resilience at all levels, reduce poverty and improve inclusive socio-economic growth.

**Progress to date:** An initial joint scoping mission was held in Kampala from 19 – 23 October 2015, and it consulted and introduced various stakeholders to the SPCR process, and guided the prioritization of thematic areas for the SPCR. Thereafter, a joint technical mission was held in Kampala from 16 – 25 March 2016, and it (i) finalized implementation and fiduciary arrangements for the Phase 1 activities, (ii) identified initial activities for the SPCR thematic areas through multi-stakeholder consultations, and (iii) reinforced consultation mechanisms and collaboration opportunities with development partners, civil society and other stakeholders.

In March 2016, a National Climate Change Consultant was engaged to support the GOU in (i) stocktaking and gap analysis of climate resilience issues in the agreed thematic areas, (ii) preparation of TOR for specific analytical/technical studies to address key gaps to inform the SPCR, (iii) facilitating stakeholder consultations for the SPCR preparation, and (iv) facilitating joint technical missions. Currently the consultant, through stakeholder consultations and review of various key sectoral plans and documentation, has identified priority activities for the agreed SPCR themes, as well as possible gaps to be filled through analytical studies. TORs for consultancies to undertake these analytical studies have since been prepared including an outline table of contents for the SPCR. The National Consultant is being reinforced by an International Consultant engaged in May 2016, whose work involves further supporting the GoU in (i) elaborating priority transformative investments for the SPCR, (ii) synthesizing vulnerability assessment knowledge and identifying gaps, (iii) drafting the SPCR and its Results Framework, and (iv) building the capacity of stakeholders during the SPCR preparation process.

**First Joint Mission:** These Terms of Reference are intended to guide the First Joint Mission that will be led by the Government of Uganda in collaboration with the Multilateral Development Banks (the African Development Bank and the World Bank) to review progress and advance the elaboration of the SPCR Investment Plan. This joint mission will involve multi-stakeholder and cross-sectoral consultations with key national, sub-national and non-state actors. It will also involve field visits to appraise climate change impacts and capture views from local level actors and potential SPCR investment beneficiaries. The mission activities will be led and coordinated by the Ministry of Water and Environment (MWE) and the PPCR National Focal Point anchored in the Climate Change Department (CCD) of the MWE.

### **3. Mission Objectives**

The Joint Mission will assist the Government of Uganda in consultation and prioritization of key activities to be incorporated in the SPCR. The objective of this mission is to (i) finalize and firm up the SPCR's priority activities and key analytical studies to inform the SPCR, (ii) review and refine the first draft of the SPCR, and (iii) identify expert reviewers for the SPCR. The mission will also plan for the Second Joint Mission, tentatively scheduled for 29 August – 2 September 2016.

The main activities of this mission will include:

- a) Finalization and firming up of priority activities for the SPCR and key gaps/issues for further analysis:
  - (i) Review and synthesize key findings from ongoing climate stocktaking;
  - (ii) Evaluate analytical work carried out to inform the SPCR and recommend additional analytical and technical studies to be carried out;
  - (iii) Undertake consultations to finalize and firm up specific activities for the SPCR;
  - (iv) Undertake field visits to assess pertinent climate change issues, consult local level actors and document lessons from existing/ongoing adaptation interventions;
  - (v) Engage Development Partners and other partners to explore their possible funding and support to implementation of SPCR activities;
  - (vi) Elaborate and agree on the PPCR activities that may be necessary for necessitate collaboration with the FIP.
  
- b) Reviewing and refining the First draft SPCR
  - (i) Revise the first draft SPCR to capture finalized priority activities and new key findings;
  - (ii) Update roadmap for the SPCR preparation.
  
- c) Identifying expert reviewers for the SPCR
  - (i) Identify expert reviewers to carry out technical reviews and quality assurance of the draft SPCR.
  
- d) Planning for the Second Joint Mission
  - (i) Draft a program of activities and expected outputs that will lead to the Second Joint Mission

#### **4. Mission Outcomes**

Mission outcomes include the following:

- (i) An Aide-Memoire highlighting the confirmed SPCR priority activities and required analytical studies, agreed activities for collaboration with the FIP investment plan and a revised SPCR preparation roadmap. The AM will also include an Annex summarizing ongoing activities on climate resilience in the country by the government, NGOs and development partners;
- (ii) Confirmed First draft SPCR, and
- (iii) Draft program of activities for the second Joint Mission.
